Year in Review

The Residence

- MCH's reputation for outstanding programs continued in 2009. The varied
 offerings included Shakespeare for Fun, "MCH Reads" book club, Little Black
 Dress Fashion Show, Gallery Night for the Interfaith Art Exhibit, and the Patio
 Pops concerts. Residents traveled to museums, concerts and the theater in
 Milwaukee and Chicago. A grant from Milwaukee IrishFest Foundation brought
 Irish music and dance performances for St. Patrick's Day.
- Activities covered diverse interests including guitar and voice lessons, book buddies, gardening, quilting, plus wellness and exercise classes such as yoga, mind aerobics and tai chi.
- Residents welcomed clergy from St. Monica, St. Eugene, Three Holy Women, Old St. Mary's, St. Robert, and Holy Family Catholic Churches to special luncheons reuniting parishioners.
- Thanks to generous donors, a player piano brought beautiful music to the foyer outside of the dining room.
- Guest rooms were made available to prospective residents considering a move to The Residence. Experiencing life at MCH first hand helped guests decide if the move was right for them.
- The Corridor Renovation Project was completed, including updating the theater, computer room, library, game room, and reading room.

Health Center

• The Health Center served residents in skilled care, ortho-rehab, respite, and special care for people with memory loss. Activities and programming covered a broad range of interests from baking residents' personal recipes to touring the city of Milwaukee and enjoying community events brought to our campus. Year-round the Health Center was alive with concerts, seasonal entertainment, exercise and wellness, ballroom dancing, and worship opportunities.

- Nursing and direct care staff continued to uphold the highest performance and quality standards.
 Milwaukee Catholic Home is one of only five facilities in Wisconsin to be accredited by the Continuing Care Accreditation Commission.
- Staff from nursing, recreational therapy, social services and food service used the new CareTracker[®] system to document, track and access data for all activity and assistance provided for each resident.

The CareTracker kiosks are strategically placed on all units to provide increased efficiency. We also designed our own systems as my department did and personalized them for appropriate data output. It also assists us in identifying trends to increase quality of care and track data more efficiently.

- Effective October 1, 2009, all 122 beds in the Health and Rehabilitation Center became Medicare certified. At the same time, the Subacute Unit was expanded to 15 rooms by December 2009 and to 18 rooms by January 2010.
- MCH's Restorative Care Program was initiated, focusing on restoring the physical functioning of residents.
- A grant from the Helen Bader Foundation provided funding for a study focused on the use of "Exercise, Strength and Balance Training to Decrease Falls Among Individuals with Dementia and Alzheimer's Disease."
- To help staff remain at the leading edge in best practices, MCH provided tuition reimbursement and professional training. This investment in training enhanced quality of care and increased staff retention.

Assisted Living Activities

- From the Family Christmas Party to Chinese New Year, residents
 experienced a variety of cultural and ethnic events year-round. After a
 resident of Sicilian ancestry suggested the idea, the St. Joseph Table was
 added, introducing interesting new foods and customs celebrating the
 fulfillment of a promise made to St. Joseph for his assistance in a time
 of family or personal crises. Two Korean graduate students volunteered
 throughout the summer and hosted a Korean Cultural Party featuring
 homemade delicacies and a slide show of their homeland.
- A new monthly music series presented entertainment ranging from a Celtic performance to favorite songs of the '40s and '50s.
- Ongoing programs included the monthly Women's Breakfast and the Men's Lunch, outings to area restaurants, and service projects. As always, the annual Spring Tea was a highly anticipated event.
- To support caregivers who need temporary care for a family member, our Assisted Living Respite Care Program was expanded.

Generations Adult Day Center

- Generations Day Center (GDC) increased its licensure from 35 to 40 clients. In a supportive, closely-knit environment, clients enjoyed recreational activities that also improved skills needed for independent living. Each week the center helped nearly 60 clients to continue to reside at home or with family caregivers.
- GDC served an increasing number of younger clients, responding to the needs of more people with non age-related challenges.
- GDC worked closely with the adjacent day care center operated by Columbia-St. Mary's. The intergenerational aspect has shown significant benefits to both groups.

The Pastoral Care Department

- The Pastoral Care staff provided for the spiritual care of residents, families and day center clients. This was accomplished in a number of ways including Mass and the Sacraments, other denomination services, meditation opportunities like Taize and Lectio Divina, education opportunities, counseling, and referrals to support groups.
- Pastoral Care was visible and active in all areas of the Milwaukee
 Catholic Home and provided support and counsel to residents and
 their families during transitions from one area of MCH to another.
 Their presence and ministry in the everyday experiences enabled
 them to bring comfort to family and friends at the moment when
 their loved one returns to the loving presence of God.

- The U.S. Postal Service honored Adult Day Program Manager Bonnie Anderson with a "Women Putting Their Stamp on Metro Milwaukee" Award in the "Volunteerism" category. Bonnie is an active volunteer in the cancer education and support community.
- MCH Director of Recreation Therapy Bridget McNair was published in *The Annual* in *Therapeutic Recreation* for her research on "the effects of intergenerational programs on individuals with Alzheimer's disease or dementia." The study examined the effects of intergenerational programs on adults who have dementia and explored the younger generation's perceptions of the elderly. This study's findings revealed that affect, attitude, ability to form relationships, group conversation, and memory significantly increased for elders involved in programs with adolescents and an overall increase in active participation when young children were present.
- Karen Rasmussen, Rose Marie Hansen and Nancy Adams were nominated for Nurse of the Year in 2009. The award honors nurses who exceed patient expectations, are compassionate and caring, are dedicated to upholding standards of professionalism, and make a difference on a personal level for patients and their families.
- For her achievements in activity programming, Katie Rutz, MCH's Recreation Coordinator for Assisted Living was named Wisconsin Activity Professional of the Year. She also competed for National Activity Professional of the Year.
- MCH hosted an intern from the University of Wisconsin-Eau Claire School of Health Care Administration and provided on-site training for nursing students from Marquette University, MSOE and MATC, as well as nursing assistant students from Quality Care Healthcare Options, C- Ross, and MATC.
- Thirty-one employees were honored for reaching milestones of service. Their longevity represents a combined 285 years of experience. Top longevity awards for 2009 were presented to Linda J. Milanowski for 20 years and Gloria Jean Armstrong for 30 years. In all, our 267 employees represented more than 1,750 years of experience at MCH.



MCH Angels successfully completed their second year of Co-ed Adult Softball. Three independent living residents and a volunteer from the community coached the 20 staff members from numerous departments throughout MCH.

MCH-A Community That Believes in Giving Back

- MCH provided funding for a parish nurse for two eastside parishes.
- Through "Nurses Affecting Change," MCH Nurses reached out to women and older adults in the community, through health fairs at inner city parishes. The nurses conducted early testing for breast cancer, diabetes and macular degeneration, and distributed important health information. The program was funded by a \$16,500 grant from Susan G. Komen for the Cure®. MCH also distributed certificates for women to receive free mammograms at Columbia St. Mary's Hospital through the hospital's grant from the National Institutes of Health.
- Residents and staff joined in various MCH raffles, with one-half of the proceeds going to local charities.
- Last year MCH residents, volunteers and staff contributed more than \$1,000 in donations to Habitat for Humanity and Goodwill and over 1,200 personal care items to area meal sites, shelters and ministries.

Volunteers Gave Very Special Gifts

In 2009 more than 85 non-resident volunteers donated 5,102 hours. They were joined by 65 resident volunteers who contributed 3,044 hours for a combined 8,146 hours. Volunteers helped with recreational activities, ran the Emporium, escorted residents, visited one-on-one, managed the library and book cart, assisted at special events, and served in the chapels.
